*Chief Report-TJ Williams

- -Thanks for the calls we had lately.
- -we are short on training, TJ takes the blame for it. We will start back up in January.

-radios for Jefferson County are live with Jeff/Lewis in them. there have been 5 issued to the officers. If you have a Lewis county radio, turn it in. there is paperwork for them.

-fire police course is canceled due to lack of interest.

-fire officer course in January, let a Chief know.

-we have a problem on fire scenes, even here at the station with personnel. A couple of officers/captains/chiefs have come to TJ. If an officer asks you to do something nicely, please comply. We are elected. If you don't feel you need to do it, that's your choice. We are going with rules. PESH is down our throats to make the department look good. It comes down to training and fire scenes. Responsibility. People have been here many years, but the officers have duties. If they demand something, don't do it, but if asked nicely, lets look professional and move on.

-TJ will be out of town on Saturday in Rochester for wrestling tournament. Rescue truck with Mark Souva will be gone for Shop with A Cop. Mark has permission to take his wife Katrina to Shop with a Cop, she is auxiliary. There is no issue her riding in truck.

-need a couple for Saturday night for Rodman's Banquet, please let TJ know. We need to know by tomorrow. Social hour is 6 and dinner at 7.

-Rescue Truck-Northern Fire has not returned calls in 3 weeks, oil leak and clunking noise in drivers side, nothing serious. TJ would like to send the truck to Stadium, Syracuse, Pierce to get repairs done. We have \$10-\$15000 for truck repairs in the budget. We don't have a price. Do we need Board approval, Membership approval, quotes? It needs to get taken care of. Scott Alexander said take it somewhere. It may be down a couple of weeks. We may have to roll more than one truck if we have to. Scott Alexander says if it goes over what we have, can we take from general fund.

-for the last forever, when we come back from a nighttime call, fire police can't be seen. We need a best practice for fire police to be in their headlights to be seen.

-Scott Alexander said, why can't we shut the lights off and have parking lights on? It could be easier. Mutual aid parks facing you with headlights on high beam, but they need to be seen

*Fire Police-Jerry Flanders

-it would be appreciated if you have a blue light and going to a fire call or coming to a fire call, please use them. They can't tell whether you are a fireman or not unless they are stopped. Please use them.

-opportunity to talk to a past president, checked with the State. There is a woman from the State Health Department. Fire police do not need CPR/first aid or AED training. To let everyone know, PESH and state health department are not on the same page. There was a clarification.

-will need fire police Friday for parade. Starts on Washington Street at 2 pm.

-January 8th, LCFP annual dinner in Glenfield. Please RSVP to the card you get in the mail.

-Wayne Hanse passed today. His wife is Treasurer of the Northern NY association.

*President's Report-Jim Henry

-On PESH, records have been misplaced. There are people here that are not showing the training that they have had. Even the now exempt members, there will be a letter saying what they are lacking and are in need of. There is a lot of paperwork, we have records of what was talked about.

-letters were sent out to the people delinquent. One back at this time.

-grant for the tanker, after going back and forth, have everything straight. Ready to go forward. Got a letter of support from Congresswoman Stefanik. Will be sent in. That will go in in the next couple of days.

There will be no further charge accounts in the name of the FD without permission of the FD. Lynn indicated we are making policies, what is it going to take one night at a meeting to vote on it? Yes. Jim said it takes 2 months to change the bylaws. There will be a binder on top of the computer with all policies for public access.

-Terry Williams-TJ is going to get cable channels back. TJ got new cable box, new internet modem. \$260.00 for bill. ¾ is the internet. Cable is \$40.00. we don't have the same package. TJ called this morning. We have a basic cable package. Before was basic and standard. We will call tonight to add the standard, but will go up \$34.00 for the standard package. Phone is also on the package. It will be less than \$300.00.

-incorporation papers, Terry calls 4 times a week, with no return call.

-Intake Valve ordered? TJ said yes. Couple of weeks, along with Hard suction hose.

-Light outside that was mentioned, are we doing that? Yes, we didn't get what we needed yet. TJ indicated that the village got approved for the 5 lights around the building to be replaced with LEDs. We will fix the light with the eye.

-Tape recorder. Tape recorder will be used when the secretary is not here.

MOTION CARRIED

-We got a contract from Harrisburg that is down \$6,000 and \$10,000 from last year. We talked with Lowville and they said the windmill money was done last year. Lowville hasn't don't down and they get 2% forever. We are now not being split. What do we want to do with the contract. Bill Henry indicated we have to go to the meetings. Terry Williams indicated it has been mentioned many times. Reports and budget have been sent to them. The budget is set. Harrisburg's Third Tuesday of the month at 7 pm. The mayor signed the Denmark contract last night. TJ called Craig Rowsome, their budget guy and said we got a 2% raise every year and that's split in half. They passed their budget and that's what we have. Going forward, as a board, we have to attend the meetings. Jim said that they should go up and talk to them to ask why we are getting the decreases. Scott Alexander asked if we presented the contract to them? Jim said that we sent a letter asking for the same. TJ indicated that in the file with Harrisburg, as far as 2015, there is a signed contract with no increase. We need to find a way to get back up to a split with Lowville. Scott Doyle indicated that all districts are different, but just check on the tax bill. Look for the fire protection district paperwork.

-Scott Alexander asked the status of the bus. No power. Is it being used for anything, even if running? Do we take it anywhere? Not now. Scott said if and when we get it running, is it worth keeping, or should we pile it now? Looking for a new one. Jim indicated that it might be worth getting rid of. We are looking at Long Island to get a new one.

-Pumper out back that we used for field day for drill team. It doesn't look like there is going to be drill team racing, but when the time comes, will it be usable? Jim indicated that it won't freeze up because there is nothing in it. We had it running last summer.

*New Business

-Shane Henry-Buildings and Grounds, we are losing BTUs from underneath the garage door out front. We have called the garage door people many times. They are overhead doors. We want the plexiglass fixed in the one door. Jim will look tomorrow to see who to call. We can probably measure the width of the door and buy the rubber stopper and change them all. Scott Alexander will look into it.

-Scott Alexander-for Jerry Flanders, don't stand on route 12 with reflective vest on. Cannot be seen. They are paying attention to lights and not him. Just don't stand there for his safety. Jerry indicated he was told by a former chief to stand there fully dressed to do that. TJ indicated they will stop for firetrucks, but if Jerry gets hurt, TJ has to answer to the mayor for why he is standing in the road with a truck rolling. People are not paying attention to the fire police, but are paying attention to the lights of the trucks.

-Sandy Peck indicated working with Brandy to get things moving a long, there are a lot of procedural and process changes. Work with us. using the audit committee to be approved before the meeting date. You can't hand Brandy a bill on the day of the meeting, it will be held up for a month. Brandy indicated she needs bills 3 days in advance. We now have standing approval for certain bills. Starting January meeting, we are trying to work off budget. When making motions for payments, we need a dollar amount, and where it is coming from in the budget. We have to live in the budget. We are taking a big hit on the income. On Treasurer's report, never included drill team accounts. It's going to take a month or two to get her up and running. Accounts haven't been reconciled in a year or two. We have to find bank statements from 1 or 2 years ago. Things aren't as tidy as they were on the hand-over.

-are bank statements in the mail? No. we have electronic bank statements. It has to be to the auditor or treasurer. Roger indicated he doesn't know why they can't get bank statements. Jerry indicated that Heidi received them.

-TJ indicated that we were talking about nominees. Only ones that hold terms are President, Secretary, Treasurer and Chief. Treasurer can only be a treasurer for 4 years. Same with the Secretary. There is no bylaw clarification for appointed members. This department is getting smaller and smaller. There should not be terms on any position, besides board of directors. If you don't have another treasurer in 4 years to replace her, then what. If you don't have someone in 6 years that qualifies for Chief, then what. Mark Souva indicated that's something for Pinskey. Come January, who is getting elected? Vice President, Board of Directors.

-Sandy indicted that the Treasurer should not be in a position of treasurer because of the propensity of theft in small departments, based on State guidelines. It can be proven because it happened here.

-TJ indicated that it has been going on from Monday to today. If there are more than 3 people talking about fire department business, is it a meeting. We will look it up.

-Christmas parade, Fire police are in charge, make sure that there is PPE and

radios.

-Talked about re-doing the room, pine 4 foot up and then drywall and paint. We know the watertown wall needs to be done. Between now and next month we will figure out how much it would cost with a proposal. Jim has 3 Amish people that would be willing to do the work. TJ indicated that we have \$10,000 in funds.
