Subject: Request for Permission to Install Broadband Equipment at Village Waste Water Treatment Plant

Dear Members of the Village Board,

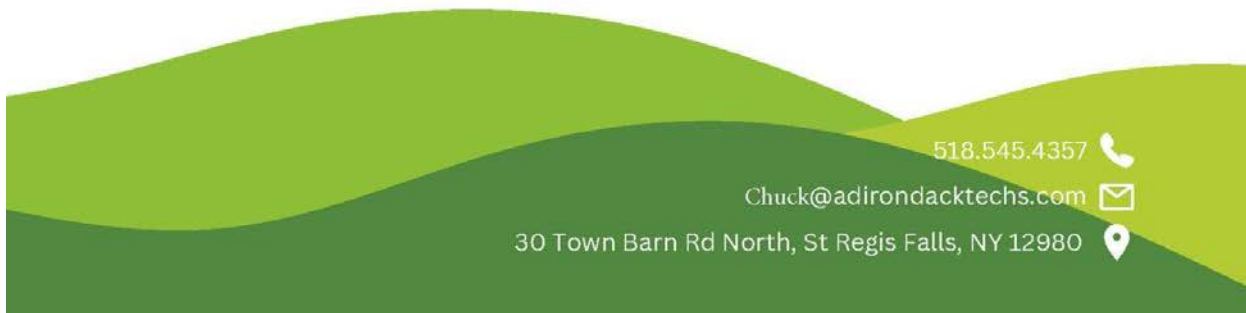
My name is Chuck Robertson, and I represent Adirondack Techs. We are currently working in partnership with Jefferson County on an initiative to expand broadband access to the Pleasant Lake community.

As part of this expansion, we have identified the Village Wastewater Treatment Plant on Stoddard Road (S Lake Road) as an ideal site for a small “micro-pop” installation to serve the surrounding area. Our proposal is to work with the Department of Public Works to determine a suitable location on the property for installing a small power pedestal and cabinet to house our network equipment.

In appreciation for the Village’s cooperation, we would provide the Wastewater Treatment Plant building with complimentary high-speed internet access. This service would be included at no cost to the Village for as long as our equipment remains on site.

For your reference, I have attached a photo showing an example of what our installation would look like. The setup is compact, low-impact, and would be professionally installed to meet all applicable codes and standards. We respectfully request permission from the Board to proceed with this project in collaboration with the DPW. We believe this installation would be a key step toward improving connectivity for Pleasant Lake residents while also benefiting the Village’s own facilities.

Thank you for your time and consideration. I would be happy to attend a Board meeting or meet with any appointed representatives to answer questions or provide additional details.

The principal of this bond is payable in funds available on or before the due date and in any coin or currency of the United States of America which at the date of payment is legal tender for the payment of public and private debts. In the event of any default in the payment of the unpaid principal of this bond on the earlier of the MATURITY DATE or the date of earlier mandatory redemption, the Recipient promises to pay interest on said unpaid principal to the Registered Owner named above at the rate of twelve percentum (12%) per annum on and after said MATURITY DATE or date of earlier mandatory redemption until said unpaid principal sum is paid in full.

This bond is one of an authorized issue (collectively, the "Bonds"), the principal amount of which is \$1,641,108.00, the bonds of which are of like tenor except as to number, maturity, denomination and interest rate, and is issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (the "Law"), a bond resolution duly adopted by the Board of Trustees of the Recipient, on June 26, 1997, authorizing the issuance of not to exceed \$3,200,000.00 serial bonds of the Recipient to provide funds required by the Recipient to construct a wastewater treatment plant and collection system (the "Resolution"), and a Certificate of Determination executed by the Village Treasurer of the Recipient dated as of August 30, 2001.

This bond is transferable or exchangeable, solely in accordance with the terms of the Project Financing and Loan Agreement dated as of August 30, 2001 between the Recipient and the Corporation, only upon the books of the Recipient kept for that purpose, by the registered owner hereof in person, or by his attorney duly authorized in writing, upon the surrender of this bond together with a written instrument of transfer or exchange satisfactory to the Recipient and duly executed by the registered owner or his attorney duly authorized in writing, and thereupon a new bond or bonds, in the same aggregate principal amount and of the same maturity, shall be issued to the transferee or the registered owner in exchange therefor upon the payment of the charges, if any, therein prescribed.

This bond shall be subject to redemption prior to maturity, in whole or in part, at any time, at the option of the Recipient, from any moneys available therefor, in inverse order of maturities, at the redemption prices of 100% of the principal amount of such Bonds or portions thereof to be redeemed.

Any such redemption, either in whole or in part, shall be made upon at least thirty (30) days and no more than sixty (60) days prior written notice to the registered owner hereof.

Unless otherwise agreed to in writing by the Corporation, the Recipient Bonds shall be subject to mandatory redemption prior to maturity within five Business Days next succeeding the date on which the Recipient receives any other grant or loan proceeds ("Other Proceeds") which are used to finance costs of the Project which have been financed with the proceeds of the Recipient Bonds; provided, however, that such Recipient Bonds shall be subject to such mandatory redemption solely to the extent of, and in an amount equal to, any such Other Proceeds received by the Recipient on or after the date of issuance of the Recipient Bonds.

In the event the Recipient shall appoint a fiscal agent, the moneys necessary for any redemption of Bonds shall be paid to or deposited with any such fiscal agent prior to the redemption date.

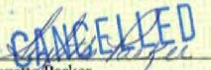

Re: Delinquent Water and Sewer Re-levies

Dear Mayor Souva:

This letter is to inform you of a change to the process for the re-levy of unpaid water and sewer rents. In the past, the Lewis County Treasurer's Office would send your clerk/tax collector a spreadsheet for unpaid taxes and the clerk/tax collector would include additional water and sewer delinquencies to be re-levied on the county/town tax bill.

I have investigated this and further conferred with the county attorney and this process is not supported by Village, Municipal Home Rule, or Town Laws of New York State. According to Village Law §11-1118, water and sewer re-levies can only be added to a village tax roll upon the certification of the board to the village clerk and must include such amounts in the annual tax levy. There is no statutory authority for a village to require a town to levy such amounts on the town tax roll, or for the town to do so at the request of the village.

This change only affects the re-levy of water and sewer delinquencies on parcels which are inside your village limits and does not change the procedure for re-levying delinquencies for water rents on parcels outside your village limits.

Please advise your clerk/tax collector that new or additional delinquencies cannot be included on the spreadsheet supplied by the treasurer's office in late October. No new or additional delinquencies will be added to parcels and the amounts will not be paid by the county when they reimburse the village for other tax delinquencies.

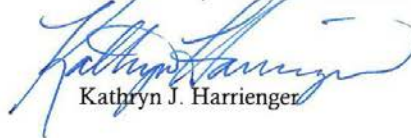
This letter responds to the Village's inquiry regarding updates being made to the Village Property Maintenance Law. The following steps should be followed in order to validly enact legislation.

1. The draft Legislation should be introduced by a member of the Village Board where it may then be considered, revised, etc. The Local Law must be in final form on the desks of each Village Board Member for at least seven (7) calendar days except in an emergency.
2. A Public Hearing should be held through the use of the Village's official newspaper. At least seven (7) days must elapse between the date of publication of the notice and the date of the Public Hearing.
3. The Village Board may vote on the Local Law at any time after the Public Hearing.
4. A Local Law must be filed with the Secretary of the State within twenty (20) days after approval.

I enclose a proposed Local Law, Resolution, Notice of Public Hearing, and NYS Filing Form for your consideration. Feel free to contact our office with any questions or concerns you might have in this process.

The intent of the proposed action is to repeal "Section 18: Emergency Actions" which exists in the Village of Copenhagen Property Maintenance Law (Local Law No. 4 of 2010) and replace the same with a new "Section 18: Emergency Actions" within the Property Maintenance Law of the Village of Copenhagen.

Once the existing Section 18 is repealed, it shall be replaced with the following:

Section 18: Emergency Actions

Where it reasonably appears that there is a present danger to the life, safety, or health of any person or property and such danger is attributable to unsanitary conditions related to garbage, litter, refuse, rubbish, and/or debris, and that such danger will exist until the offending garbage, litter, refuse, rubbish, and/or debris is removed, the Village Board may by resolution authorize the immediate removal of the same. Written notice of the same shall be provided to persons having interests in the property within a reasonable time and such notice shall be posted at the property.

The actual cost of correcting such condition [minimum charge of one (1) hour labor and one (1) hour equipment, plus materials], plus five percent (5%) thereof for inspection and other costs in connection therewith, shall be calculated and certified by the Village Clerk and shall thereafter become and be a lien upon the property whereon such condition exists and/or is located and shall be added to and become a part of the taxes next to be assessed and levied upon such lot or land and shall bear interest at the same rate as taxes and shall be collected and enforced by the same officer and in the same manner as taxes.

The printed introductory bill number for the proposed local law and explanatory matter must be omitted.
6. The date of filing of a local law is the date on which the local law is placed on file by the Department of State. The Department of State will assign a local law number for indexing purposes. The Department of State's Index Number for a local law may be different from the local law number ascribed by the legislative body of the local government.

It is suggested that municipalities use introductory identifying bill numbers for proposed local laws. After the local law is enacted (and approved by the voters, if required), the local law should then be numbered and submitted to the Department of State for filing.

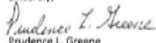

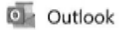
